





























The year 2021-22 was another tumultuous year with the surge in COVID cases and two lockdowns. Our team however continued to work relentlessly to overcome the challenge and we are happy to share our work through this edition of our Annual Report. We extend our deep appreciation and gratitude to our team and all our partners, donors and well wishers for their support during the critical time.

The second wave and subsequent lockdown led to the closure of educational institutions, yet again. To maintain the education engagement of our students our teachers sent worksheets online. However, for 70 grade VII students we launched the Alternate Delivery Model, a pilot project with a purpose to enable students to have access to education through internet enabled tablets. Mothers and community Leaders were an integral part in delivering, collecting and monitoring the tablets.

During the lockdown, parents expressed their anxiety and were worried regarding the safety of their girl children as most parents would be away on work and the children were left on their own. Moreover some children were faced with domestic violence. We shortlisted 30 children- the most needy, and opened a Day Care Centre where these children were provided with online education, nutritious meals, co-curricular activities and other development and recreation opportunities. We gradually reopened the Learning Centre in a staggered manner and a summative assessment was conducted in August 2021 to assess learning loss levels. The results were a concern as they reflected a huge learning loss. This led to a need for intensive remedial support to bridge the gap. The remedial program was implemented along with regular grade sessions to help students learn foundational concepts and skills while regular grade sessions would help a child stay informed about grade-level concepts and skills.

The highlight of the year was the launch of our mascot-Tara and, publications of two books on COVID 19 and Climate Change to generate awareness among young minds. We distributed these books across the country through 70 partners. Yet another achievement was the initiation of the Library Project, "The Story Hub" aptly named by the children. It is now a vibrant space for story narration,

During the year we successfully transitioned our Grade 7 girls to a leading school in the city. We have also enrolled children in our L1 section after a gap of almost two years.





Ek Tara Learning Centre (ELC)

The Ek Tara Learning Centre (ELC) was launched in 2021 to house all of Ek Tara's Education and Child Development programmes. It provides access to high quality learning resources to 950 students. This state-of-the-art facility which is spread across 3 floors and an open terrace has 22 large classrooms, an integrated Science and Math (STEAM) lab, an art room, a music room, a library, a multipurpose hall, an indoor game room, and a sick room.



We cater the following programs for the centre:

- Early Childhood Learning Centre (ECLC)
- Primary and Middle School (Pri & Mid School)
- School Support Project
- Child Welfare and Parental Engagement (CWPE)
- Mentorship
- Digital Literacy
- Co-curricular Activities (CCA)
- Health, Hygiene and Nutrition



There are 17 SDG's and 169 targets in total. While they are all important and interrelated, Ek Tara works actively on the above goals.









Early Childhood Learning Centre (ECLC)

The center reaches out to over 200 children aged three to six years. Its aim is to develop a strong foundation in literacy, numeracy and other development indices for young girls - supporting the overall development of the child so they are ready for primary school.

Primary and Middle School (Pri & Mid School)

The primary school encompasses classes 1-4. Together with the middle school, it reaches out toover 500 students. Apart from regular classes our children partake in various co-curricular activities. There is also a robust Remedial Project designed for children who are unable to cope academically in their classes. This post school remedial project involves trained teachers equipped to handle remediation for classrooms which have children with mixed abilities and capabilities.

School Support

Over 250 students are part of this project, who are enrolled in various schools across the city. All children graduating out of the Primary and Middle School projects are enrolled across 7 partner schools covering 3 major boards. All their school related expenses are borne by Ek Tara in addition to looking after all their academic and other developmental needs.

Health, Hygiene and Nutrition (HHN)

The aim of this project is to ensure good health and hygiene practices among all Ek Tara children and their families. Nutritious hot meals and snacks are cooked and distributed daily to address the problem of poor diet. In addition, children and staff have access to health workers and hospitals when needed. During the Covid-19 pandemic, this project also provided relief material to over 30,000 individuals and families across the community who were in need of food and medical supplies.

Co-curricular Activities (CCA)

In addition to covering all academic support for all children enrolled in Ek Tara's care, we offer a range of activities as part of our curricula for all students. At the primary level we offer a minimum of 3 activities to all our children for them to explore their interests and talents. Over 700 students were part in these activities, held throughout the last year. Our children had the option of choosing from a wide variety of activities such as dance, music, drama, art & craft, swimming to name a few.

For all students of Ek Tara there are digital classes to support their academic development. These classes include the use of smart boards, laptop based classes, computer practicals and tablet based learning. These classes enable children to use technology in everyday life.

Mentorship

Ek Tara has developed a unique mentorship program wherein children enrolled in the school support project are enrolled as mentees under various specialised mentors. These mentors come from different walks or life and are accomplished in their own fields. The interactions with the mentors allow children a wealth of information which goes into shaping them. Mentors oversee not just their academic growth but their overall development and facilitate access to career counseling, life skills among other activities.

Child Welfare and Parental Engagement (CWPE)

Ek Tara focusses a great deal on building capacities of the families of the children and women it works with. Under the CWPE vertical the wellbeing of each child is looked into in a manner that extends beyond the classroom. This includes home visits, focus group discussions with parents, implementation of the robust Child Protection Policy to name a few. Various information sharing workshops and training are offered to parents so that they are able to provide the support their children need to continue in school and eventually be prepared for college and be job ready.


National Education Policy

In the month of March, 65 new books were procured for the Library. We were selected to be part of Parag Honour List (PHL) Book Box 2021 and received 14 books.







Let's Talk Climate!

The Let's Talk Climate campaign was designed to lead up to the COP 26 summit, held in Copenhagen in 2021. For a month, 20 studentsformed the climate change focus group-and worked on activities that ranged from learning to reduce, recycle and reuse to understanding the impact of climate change on habitats and food security.



Workshop by Goethe Institute

A number of experiments based on basic concepts of science were performed by two demonstrators for teachers and educators to encourage students to conduct such experiments for better understanding of the concepts. The teachers also got a link to films and documentaries based on environment issues, to be shown to the students as per requirement.



MyStemZone

This workshop was conducted for the science teachers to familiarize them with the MyStem Zone science kits for the STEAM Lab



Zero Waste Workshop

This workshop was facilitated by Her Future Coalition. A short talk and demonstration, this session was conducted by resource person and Zero Waste influencer- Lata Bhatia, on waste reduction, natural cleaning supplies, composting and climate change.

Computational Thinking Workshop

Teachers participated in the Computational Thinking in Schools webinar. It was organized by ACM India and CS Pathshala community. The aim was to bring teachers educators and researchers to discuss issues of curriculum, pedagogy, policy and implementation related to bringing

computational thinking to schools.

- After a general health screening at Ek Tara 30 children got free vitamin supplements.
- Free medication was provided to 50 students.
- 35 mothers participated in an awareness session on the benefits of a balanced nutritional diet.

Heath, Hygiene and Nutrition Highlights

When asked about the three wishes Alisha would make to a genie, she quoted, "I want to erase my mother's past memories."

This is the story of Alisha Khatoon and her parents' struggle to overcome the hindrances they had to face in getting their children educated.

Clichéd as it may sound, even in today's context, many girls face discrimination, when they exercise their basic rights to be educated and Alisha's case is no exception.

Alisha Khatoon lives with her family that includes her parents and a sibling. The family juggles urban and rural life to keep pace with the children educational requirements. They have a house in the countryside, but reside mostly in the city, in a ramshackle compound. Their room is a small dilapidated enclosure and they share a common toilet space with 30 other people.

Alisha's father repairs bicycles and her mother works as a maid. Collectively, they earn a meagre salary of Rs. 8000/-Alisha's mother has been facing domestic abuse by her in-laws since her marriage. This information was brought to our notice by Alisha. Alisha's mother is determined to give her children a better life which encourages Alisha to keep pushing herself.

Both her parents are extremely supportive of their children education and are active participants in contributing to their education. They don't allow any obstruction in their way, even if that involves resistance from their relatives.

Alisha's mother aspired to be a painter but her dream was cut short due to an early marriage.

Alisha's academic performance is good and she excels in all her subjects. Lately, she has taken to creative writing which she enjoys a lot. She writes with depth and insight. She plays an active role in discussions and has enhanced group discussions. She has won certificates for elocution, dance, and music. She is extremely communicative and enthusiastic about opportunities that come her way.

At home she mentors her elder sister too. She teaches garbage segregation to her family and puts to practice everything she learns at Ek Tara.

She aspires to be a Chartered Accountant and when enquired if she has any plan B, she confidently said, "There is no plan B."

She looks up to her father for inspiration and spoke highly of how her father disregarded the typical disapproval of their relatives when she and her sister were born.

Alisha seems wise beyond her years.



Alisha's Story



Library project

The Library project at Ek Tara was consolidated as a space for reading, exploration and expression. The name for the library 'The Story Hub' was decided by the primary stakeholders-the children at the Learning Centre. The space also went through physical transformation-making the books more accessible to children, attractive, child friendly shelves, book wall hangings and art work.

Day Care Centre

During the lockdown, Ek Tara identified girls who would come under the category of 'at risk', bringing them into the centre everyday. Apart from receiving regular health check-ups and meals, the students had regular computer classes, an assessment conducted by We Can, reflection circles and remedial classes.

STEAM LAB

Equipped with basic laboratory instruments and sets of experiments, the activities under each of the other.

Remedial Project

The COVID-19 pandemic meant that with each lockdown, the students from Ek Tara were studying at home, with worksheets and online classes. While everything was done to ensure that each child was given an educational input, the lack of an inperson engagement led to a definite learning loss, a phenomenon that has been observed and recorded all over the world with the closure of educational institutions.

In order to address this loss and bring those children back towards the expected level of learning. Ek Tara initiated a comprehensive and individual focused remediation program.



Partnerships

We always believe in making the most of any opportunity that is presented to us and last year too we ensured that our team participated in various talks, workshops, training courses to spread word about our work and also to upskill ourselves across all levels. Some key partnerships include:

- Partnership with Prospero World, UK to offer benefits to donors in the UK.
- Participated at the Global Youth Summit where Ms. Shamima Khatoon one of Ek Tara's community leaders got the opportunity to talk about the importance of partnerships in the development sector.
- Each one Teach two was a partnership programme with Indus Valley World School. It was an
 online remedial support programme run by the students of Indus Valley.
- WeCan conducted classes in English and Maths for children at the Day Care Centre.
- WhiteHatJr conducted coding classes for our children.
- Partnership with the Behavorial and Discussion Making department of the London Business School as case studies.
- Participation of management team members in capacity development courses offered by the prestigious "India Leaders for Social Sector."

To increase the ability of communities and to recognize inequitable situations and realise the importance of addressing unjust situations, BCI Enriche team trained Community Leaders and Partner Organizations from 9 states to increase awareness and action on issues related to domestic violence and equality. Ek Tara was proud to be part of this initiative.

100 Cameras

The 100 Cameras project involved eight students from classes IX and X. The project included 8 class room instructions through lesson plans. The students learnt the process of storytelling through photography in a way that impacts how they view themselves and their role in their community. Each class ended with an assessment and Photo Walk, organized both within ELC and North Kolkata.

Bhumi volunteers work with our students to cater to digital literacy under their Kanini project.





Millipede

National Theatre of Scotland and ThinkArts (based in Kolkata) presented MILLIPEDE in partnership with Indian artists, scientists and climate change organizations.

The aim was to generate ideas and shape artistic responses to carbon footrpints in the face of Climate Change. 7 students from Grade VII participated in creating Fantasy Footwear and an opportunity to tell their own story by showcasing their finished pieces within the website in the hope of engaging and inspiring others. The students were awarded with certificates.

Teach for India

Teach for India, a pan India organization, began its innings in West Bengal at Ek Tara, with three fellows joining our team in January 2022. The fellows took up classes in Grades 2 and 3, moving up with the students to Grades 3 and 4 respectively. We look forward to more fellows joining us in the next academic year.

Talk To A Scientist

Six students from the Learning Centre participated in this science webinar for children between 6 to 16 years. Scientists from across the country held sessions on different science topics and engaged with the students. It provided a platform and an opportunity for the students to interact with the scientists.

CSpathshala

CSpathshala is an Association for Computing Machinery India (ACM India) initiative to bring a modern computing curriculum to Indian schools. Ek Tara worked with their curriculum to conduct demo sessions on computational thinking with grades 2, 3, 4 and 6.




- Lions Club International: Organized an eye screening and blood group typing camp. The students were given free eyeglasses post screening.
- Turnstone Global: Children from ECLC participated in an eyesight testing camp.
- Rotary Urbana: Organized an eye camp with Disha Eye care from school support programme. Free eyeglasses were distributed after the screening.

Amidst contemporary stories of sorrow, grief, disasters and losses causing hopelessness, Mahenoor is the silver lining, an epitome of light and hope. A girl who is unapologetically brave and unbelievably ambitious.

Mahenoor in Urdu means 'light', and she has indeed been an epitome of light. She has been consistent with her hard work like sunlight, making life possible on Earth.

She aspires to become a chartered accountant, and is working hard to realize her dream. She was introduced to us in the year 2006 when she was merely six years old. With no formal education or experience of attending school, we made her start from scratch.

A year later, she was enrolled to Jyotirmoy Public School wherein she studied till grade fifth, and was then enrolled to Indira Academy, She took her board examination through the same school and fared extremely well. This was one of the most important milestones in her life because she was the first from her family to have reached that level. Even her older siblings had to drop out given the financial constraint that loomed large in her growing years.



Following that, in the same year, she was enrolled to Khalsa High English School. This was another turning point in her life. The many challenges like poverty, lack of space and environment did not diminish possibilities of success in boards. Not even obligations towards household chores for she diligently burned the midnight oil and achieved 84%.

Her moment of success and joy was cut short by realities associated with age and gender. The demand to marry grew louder but she wouldn't give in. Her academic credentials enabled her admission to B.Com at the prestigious AJC College. At present, she is in fourth semester, doing what she does best- hard work and lots of

Utilizing the system designed to up skill and empower women, Mahenoor partially finances her B.Com curriculum at AJC College with employment provided by Ek Tara.

A wanting socioeconomic background, demise of her father, the sole breadwinner at a tender age, the food insecurities at home, inconsistent nature of partly financial support coming from brother's odd jobs and obligations towards household chores would not obscure the possibilities of realizing the dream because she is strong and supported by the Ek Tara system.

Coming from a vulnerable socioeconomic background and aspiring to be a chartered accountant will be called a tall order by most, while we at Ek Tara call it the story of hope and resistance.

Ek Tara is proud to present to you Tara- our very special mascot who is a champion for Girls Education! Tara represents the millions of girls in India who come from low-income homes and miss out on basic development opportunities such as access to good education, health and child rights! By way of conversations and publications Tara aims to reach out to such children across the country on myriad issues which directly impact their well being.







Ek Tara sent the COVID 19 booklets for children to Ms. Vandana Chavan, MP, Rajya Sabha. She also presented a book to the Hon'able Vice President of India Mr Venkaiah Naidu.

The impact of the COVID Booklet was also covered in the local press.

"If there is anything that has been consistent in my life, It's the misfortune."

Soma Sardar has been an indispensable part of Ek Tara ever since its inception.

Her life has involved profound struggles, and yet her face doesn't give away the pain that life inflicts on her on an everyday basis.

Soma's destitution goes back to the time when she was merely four. Her father took to drinking and inevitably, subjected them to the vices that come with it. Needless to say, he did not contribute to their upbringing, monetarily and emotionally.



Soma's Story

Soma and her siblings lived on the income of their grandfather and with the meager support that she received, she managed to go to school but, as luck would have it, her grandfather died and she had to drop out of school the same year. Her dream of getting an academic degree was cut short.

Soon after, she was married off. Her age at the time of marriage was 16 years.

Few months into the marriage, she discovered that her husband was an alcoholic. Subsequently, she had to endure domestic violence for years. He did not even spare their daughter and would beat her endlessly. To her, it was all a sense of deja vu!

The only difference here was that this time she put her foot down and decided not to succumb to the ill fate.

She acquired a home loan and with her savings through the years, she managed to get her own space which she says is her safe haven.

Every month she paid a substantial part of her salary to the bank and she could barely manage to make the ends meet. To add to the dismay, she was diagnosed with a tumor in her uterus and had to be operated upon immediately. However, she smiled through it all.

She attributes her survival to her daughter of 18 years. She has her hopes and dreams pinned on her and her drive to work relentlessly comes from there. She wants her daughter to stand up for herself and be vocal in life.

Her daughter too is extremely focussed on bringing her mother out of the clutches of misery. She aspires to be a teacher and is working rigorously to fulfill her dream. The only obstacle is the lack of money to pursue a Computer course. She wants to also enroll herself in the Spoken English classes, but is unable to do so.

Currently she works in our community kitchen
"Annam" as a cook and also helps out in the social
enterprise "Ek Tara Creates."

As for Soma, she continues to fight with the same zeal. She has been inspirational to many, and a lot of us look up to her for the unflinching courage and determination she has shown.

A year with unique challenges

Ek Tara's Community Engagement programme through the year focused on strengthening its engagement with stakeholders in the community that include, parents, youth, local clubs, ward offices among other agencies. The project worked on offering capacity building activities, vocational trainings, and creating safety networks within the community. We also conducted awareness camps on various themes including child safety, delivered play based education to children and provided relief services.

The beginning of 2021 was largely focused on dealing with challenges around COVID-19 such as loss of employment, school dropouts, early marriage among girls, increase in child labour, addressing stigma around vaccination etc. Our engagement therefore, ensured continued learning among children and their families.

Through the remaining part of the year Ek Tara also rolled out opportunities for youth from the community through theatre camps, tailoring and computer trainings and soft skills development. As 60 % of the workforce at Ek Tara are members of the community we continue to build their capacities in various spheres. These members are engaged in multiple roles ranging from leading verticals on health and nutrition and providing support to education and extra -curricular activities. Through this engagement model, Ek Tara equips stakeholders from the community and has been successful in developing and strengthening its understanding of the community members.

The programme has also engaged actively with government and local agencies to scale its work.

With a sharp focus on rebuilding the losses caused by the pandemic, the programme has reworked its strategy and re-defined its focus for the future.

Community Engagement

Partnerships

- KMCP schools This includes delivery of the Chakke Pe Kaksha programme for 4 Kolkata Municipal Primary schools in the area. The project is locally refereed to as " ananda gari".
- The Mobile School: A Belgian organisation that has created a movable educational tool that engages with children and is focused on developing selfesteem among street connected children. Ek Tara is their first partners in Asia and has been implementing the project for over 6 years across different areas in the city.
- The Alliance for Resilience city: Non profits working in the the city have come together to form an alliance to share learnings, and build a common platform that helps address the larger challenges.

Ek Tara Community Centre (ECC)

The Ek Tara Community Centre (ECC) is a 10,000 sq ft facility that is dedicated to programmes geared towards economic empowerment and social mobility of women. ECC houses the vocational training unit, income generation unit for women and creation of resources that help further Ek Tara's mission.

Ek Tara's social enterprise-Creative Ek Tara Foundation enables employment opportunities for women trained at Ek Tara thereby making them financially independent. The enterprise currently runs two projects in ECC:



"Ek Tara Creates" is an income generation platform for women trained on tailoring and hand embroidery under the vocational training programme at Ek Tara. The unit works with mothers and older siblings of girls at Ek Tara. The items created here focus on repurposing fabric that lies in excess in factories and boutiques. This model encourages up cycling of materials. Women create handmade products that are sold through various online and offline platforms across the country. The enterprise over the year participated in 5 exhibitions across the city and sold items through popular retail stores in addition to creating Jute items for large corporate events.

"Annam "

Annam is our community kitchen that engages with mothers of children at Ek Tara. The kitchen provides for nutritious, hygienic vegetarian cooked meals and snacks for children studying at Ek Tara. In addition to this, the unit also delivers cooked "Dabba" for factory workers around the area. It is a 6 member team that produces over 1300 meals on a daily basis. During the COVID -19 period. the kitchen was engaged in catering over 800 cooked meals on a daily basis for over 45 days.










Impact Report

- Since its inception Ek Tara has educated over 1500 children.
- Children moving from Ek Tara to other educational institutions continue to secure 1st division in their higher examinations.
- 60% increase in women seeking skill building opportunities.

Undertakings during the pandemic

During the pandemic we facilitated the vaccination process for all our staff. In addition to this we also encouraged and financed a vaccination drive for children aged 15 and above.

The remedial programme was started to address the learning loss that came about due to the pandemic. Over 300 students were a part of the programme in the first year.

191

To curb dropouts our community outreach team conducted 191 in person home visits.

Alternative Delivery Model (ADM)

During the second wave most of our children found it difficult to cope with their education online due to inaccessibility to smart devices and internet. But we were quick with our response and devised our Alternative Delivery Model (ADM) for the children.

ADM enabled our children to continue their classes online using tablets and internet. This ensured that our children were engaged and continued with their learning process. We piloted this project with senior children and eventually rolled it out to most of our children.

1 Overview of the Trust's Operations

A registered Trust, Ek Tara began its journey in 2011 with the mission for providing high-quality holistic education to childran and women of impoverished families to enable community transformation. As a part of its programme and projects, all beneficiaries, including those in the vocational training unit, have access to support programmes on health, hygiene, nutrition and skill building opportunities.

Its aim is also to enable future generations of impoverished people to break out of the poverty enforced lack of education.

2 Accounting Policy

2.1 Grant / Donations Accounting

All grants are accounted on receipt and expenditure and liabilities are accounted /recognised on accrual basis. Grants / donations received towards the year end and not possible to be expended within the financial year, are treated as Advance donations and necessary applications as required under the income Tax rules for deferment of expenditure to the next financial year are made by the Trust.

2.2 Grant/ Donation Accounting on specified projects

Grants /donations accepted / received towards implementation of various programmes for carrying out specific purposes are spent according to the direction of the donor agencies and unspent balances, if any, are dealt with in accordance with the instructions/arrangement with the donor agencies. Normally the donations are received to be spent within the financial years and so they are treated as income of the year when they are received, unless they are received at the year end and treated as "Advance donation".

2.3 Interest on Deposits

Interest income is accounted on accrual basis.

2.4 Corpus Fund

Donations specifically received towards Corpus are added to the Trust fund and are separately disclosed.

2.5 Fixed assets are stated at cost of acquisition.

Assets created out of a Project Grant are stated at cost of acquisition to the Trust.

2.6 Depreciation

Depreciation on fixed assets are provided on written down value method at rates provided in the income Tax Act, 1961. Depreciation on the Assets created out of Project funds are adjusted against the Capital Fund.

2.7 Disclosure and classification of expenditure

All expenditure incurred directly towards the charitable programmes of the Trust are disclosed as "Charitable Programme Expenses" and all other expenditure providing support to the programmes are disclosed under Administrative and Other expenses.

All expenses are accounted for on accrual basis.

2.8 Employee benefits

Cost of short term employee benefits are recognised on accrual basis on the terms of the employment contract and other relevant compensation policies followed by the Trust. Leave is not accumulated and are allowed to be encashed within the financial year.


